Declaration and Certification of Finances

In order for you to obtain or maintain F-1 or J-1* visa status, you will need an I-20*. Baruch will issue one upon verification of your ability to meet the estimated annual expenses shown on page 4. The I-20* cannot be issued until you supply the necessary financial documentation as described under "Required Documents" on the chart on page 4. Submitting either or both of these forms and any required documentation after admission has been offered will delay the issuing of the I-20* and jeopardize your enrollment for the term of application because you may not be able to get your visa on time.

Deferring Admission

If you are admitted and request a postponement of your admission, you will need a new I-20*. If your financial documentation is over one year old at the time of your readmission, you will need to supply new documentation.
