In addition to this Centre Aid Form, the following documents must be submitted by the established deadlines:

- 1. Mail the Free Application for Federal Student Aid (FAFSA) to the Federal processor by February 15.
- 2. If you are selected for verification, we will ask you to mail a signed, complete copy of your and your parents' 2000 federal income tax returns to Centre's Student Financial Planning Office. Please include W-2s. A Verification Worksheet will also be required.

In the event of a substantial change in family circumstances (death, divorce, or loss of employment) you may notify the Student Financial Planning Office and request a reevaluation of your award. Any potential adjustment is contingent upon your eligibility based on program regulations and the availability of funds. We suggest that you keep a copy of this form and all other financial aid forms you submit.
