Please be advised that a preliminary award is estimated and may be adjusted once tax returns and additional documents are verified. A final award will be mailed when the admission deposit is paid and all required forms have been submitted.

Option 2: To receive a final award with your admission decision, the following documents must be mailed by February 1, 2003:

- 1. this completed form
- 2. your parents' 2002 signed federal income tax return, including all schedules and W2s
- 3. the student's 2002 signed federal income tax return, including all schedules and W2s
- 4. any additional documents, as requested

Option 3: Transfer students are strongly encouraged to provide all documents as soon as possible, but no later than May 1, 2003.

REMEMBER: The FAFSA must be mailed to the processing center no later than February 1, 2003. You may estimate in order to meet deadlines. Failure to list Grinnell College may result in a delayed award. The Grinnell College Title IV Code is 001868.
